FOREWORD

Children occupy a central role in the teachings of Jesus, who pointed to the child as the ultimate symbol of the Kingdom of God. "Let the little children come to me, do not hinder them, for the kingdom of God belongs to such as these", (Lk. 18:16). This places a sacred duty on everyone in the Catholic Church, to ensure that children are welcomed, cherished and protected in a manner consistent with their central place in the life of the Church. Each child should be cherished and affirmed as a gift from God with an inherent right to dignity of life and bodily integrity which shall be respected, nurtured and protected by all. Thus, the Zimbabwe Catholic Bishops' Conference (ZCBC) has developed a Child Safeguarding Policy for all Catholic Institutions in Zimbabwe which aims at ensuring that all those who work with children and young people create a respectful, caring and safe environment where the dignity of every child is valued.

The ZCBC Child Safeguarding Policy outlines and explores the key principles and issues relevant to child protection, as well as outlining the steps that are needed in order in the holistic development of children. The principles stated in this policy can be used by any Catholic institution in our country in order to safeguard children from all forms of abuses which incudes, sexual, physical, emotional, psychological and spiritual. This policy has been developed in line with the Gospel values which promote justices and the dignity of human beings especially children as reflected in the Gospels which state that "Whoever receives one such child in my name receives me; and whoever receives me, receives not me but him who sent me." (MK. 9:37). This Child Safeguarding Policy helps our Catholic Institutions to respect the lives of the children who reflect God's love to us. In the Declaration of Rome World Congress: Child Dignity in the Digital World 6 October 2017, Pope Francis highlighted that, "A society can be judged by the way it treats its children." He also emphasised that every child's life is unique, meaningful and precious and every child has a right to dignity and safety.

The safeguarding and protection of children is everybody's responsibility. We all share this responsibility and we need to play our part actively.

May the work, initiatives and structures presented in this Child Safeguarding Policy give us courage and hope to engage in promoting the safety of children for the good of the Church and for the good of the society. May God bless us in our work.

1.0 INTRODUCTION

Zimbabwe Catholic Bishops' Conference holds that the Safeguarding of children is based upon the belief that each person is made in the image and likeness of God and that the inherent dignity of all should be recognized and fostered. We seek to make all our church activities and facilities (Parishes, Schools, Children's homes, Hospitals) safe for children.

An embedded culturally driven approach to child safeguarding and safety in all schools means that protecting children from abuse is evident in everyday thinking and practice of leaders, staff and volunteers.

Catholic Institutions are entrusted in partnership with parents, guardians and Care Givers who are the primary educators of their children with the total education of the child. Catholic institutions staff members, therefore have a duty to care for students during school operating hours and at other times when a staff and student relationship exists.

The staff members fulfill this duty by taking reasonable care to avoid acts or omissions which they can reasonably foresee would likely result in harm or injury to the student.

I.I VISION

To facilitate holistic development of children with special focus on physical, social, emotional, intellectual and spiritual well-being.

1.2 MISSION

To nurture an environment that respects, promotes and fulfils the needs and rights of children by raising partners and associates awareness of child safeguarding issues through continuous trainings.

1.4 SCOPE OF THE POLICY

Zimbabwe Catholic Bishops' Conference (ZCBC) recognises child rights and child responsibilities and the need to safeguard children from any form of abuse, harm and trafficking of persons. This policy will be informed and grounded upon the four principles of child rights as enshrined by the United Nations Convention on the Rights of the child; on-discrimination, the best interest of the child, participation and survival and development.

1.5 ZCBC PRINCIPLES

Children should be protected by employees and volunteers of ZCBC regardless of their geographic location within and outside the church property. All people both adults and children are protected by this policy, whatever their race, religion, abilities, whatever they think or say and whatever type of family they come from.

This policy shall apply to all Catholic institutions in Zimbabwe. These institutions will publicly display mission statements showing the names of the institution's Child Safeguarding Officers and Child Safeguarding Advisors together with their contact details. The characteristics encompass principles that best explain ZCBC's characteristics as follows:

a. Impartiality

Investigations into possible misconduct will be handled in an open minded and impartial manner.

b. Safety

ZCBC will respond swiftly to allegations of misconduct as well as cases of actual child abuse to maximise the safety of the children in their care.

c. Speed

Effort will be to conclude investigations in a timely manner.

d. Confidentially

The ability to remain discreet on sensitive issues or reports.

- Any details about individual cases which lead to the identification of participants will remain confidential and shared only on a need-to-know basis. This paramount to safeguard the interest of both parties.
- Care is to be taken so that investigations will not inadvertently call into question anyone's good name.
- ❖ ZCBC will take strong action against anyone who knowingly broadcasts confidential information concerning an abuse.
- It is important that the investigators should consider the safety of the perpetrator while at the same time making way for the legal process to take its full course.

2.0 PURPOSE

ZCBC is committed to safeguarding of all children in Catholic institutions in Zimbabwe. Its purpose is to offer the children a safe and welcoming environment with fun activities where the children can live, learn, grow and glow into the world with the fear of the Lord and respect for fellow human beings.

This document is to provide a blue print on and procedures to maximize the safety and protection of children under the age of 18 in Catholic institutions within Zimbabwe.

The policy sets out the procedures to be followed to ensure that prompt, professional; sensitive and appropriate action is taken by staff in Catholic institutions in accordance with the expectations of the ZCBC.

This policy applies to all staff working in Catholic institutions in Zimbabwe including priests, religious and the laity, paid staff, volunteers, casual workers, agency staff or all students on internship.

4.0 DEFINITIONS UNDER THE CHILD SAFEGUARDING POLICY.

4.1 Child - In this policy a child is defined as a person below the age of 18 years in line with the United Nations (UN) Convention on the Rights of Children and Section 81 of the Constitution of Zimbabwe (No. 20) Act 2013.

- 4.2 Child abuse is defined as ill-treatment or exploitation of children's rights which fall under the following categories: physical abuse, emotional and psychological.
- 4.3 Physical abuse is defined as the actual or potential physical harm perpetrated by another person, for example an adult or a child. It may involve hitting, shaking, poisoning, drowning or burning.
- 4.4 Sexual abuse is defined as forcing or enticing a child to take part in sexual activities, such as rape, pornography and some sexual related messages on social media. This may also include any sexual activity in exchange for money gifts, food, accommodation, affection, status or anything else that they or their family needs. It usually involves a child being manipulated or coerced which may involve befriending children, gaining their trust and subjecting them to drugs and alcohol for purposes of sexual manipulation.
- 4.5 Emotional abuse -is defined as persistent emotional maltreatment that impacts on a child's emotional development. Emotionally abusive acts include restriction of movement, degrading, humiliating, bullying and threatening.
- 4.6 Commercial exploitation- is defined as exploiting a child in work or other activities for the benefit of the other and to the detriment of the child's physical or mental health, education, moral or social-emotional development. It includes but is not limited to child labour.
- 4.7 Neglect and negligent treatment is defined as the persistent failure to meet a child's basic physical and/or psychological needs which is likely to result in serious impairment of a child's healthy physical, spiritual, moral and mental development.
- 4.8 Child Safeguarding is to afford children protection in everything keeping them safe and looking after them very well.

5.0 FUNDAMENTAL PRINCIPLES

In the best interests of the child, the child protection strategies and procedures to be followed are based on the following principles:

- 5. I Every child has a right to life.
- 5.2 Take into account the diversity of all children, including the needs of children from culturally, religiously, geographically or linguistically diverse backgrounds.
- 5.3 The institutions are expected to be safe, supportive, inclusive and empowering.
- 5.4 All staff members in Catholic institutions have a responsibility to care for children and to promote their safety, protection and well-being.
- 5.5 All children have the right to a holistic and systematic education in all aspects of life.
- 5.6 In any dealings regarding safety, the dignity, protection and well-being of children involved shall be maintained and respected.
- 5.7 Those in charge of the institutions are required to ensure that all staff members adhere to legislation and policies with respect to child safeguarding policies.
- 5.8 Children should be allowed to express themselves freely and responsibly.
- 5.9 To assist the children in integrating into the community.
- 5.10 Appropriate confidentiality will be maintained with information being provided to those who have a right or a need to be informed either legally or pastorally.
- 5.11 The child's welfare should be considered paramount in all Catholic institutions. All Catholic institutions should make this clear by publicly displaying their commitment to child safeguarding through mission statements.

6.1 CHILDREN'S RESPONSIBILITIES

Children's rights go hand in hand with their responsibilities. Rights would be empty without responsibilities.

The following are the responsibilities for children:

- ❖ To respect and care for each other.
- ❖ To be involved in decision making in issues that affects them and their needs.
- ❖ To be honest and to do what is asked of them.
- ❖ To appreciate the good things that adults do for children.
- ❖ To help at home, look after the elderly when they are ill, and care for their siblings.
- ❖ To be open and engage with their parents.
- ❖ Have good communication with their parents and elders.
- To share problems with their parents.
- ❖ To report abuse cases immediately to their parents or care givers.
- ❖ To learn how to be responsible adults in the future trough acquiring the required life skills and education.

Children also have the following responsibilities to other children;

- To avoid bullying and report any cases of bullying to the responsible authorities.
- To respect other children's rights.
- ❖ To be generous, truthful, helpful and polite.
- ❖ To make sure that fellow children are cared for and that they are not abused by their parents, relatives, teachers, neighbors, strangers or other children.
- ❖ To counsel fellow peers if they have problems and share food and other basic needs with them.
- ❖ To play with other children without discrimination or hatred and to encourage each other to study.
- ❖ To avoid laughing, mocking other disadvantaged children or making them feel unacceptable.
- ❖ To discourage that which is negative in life and encourage each other to be optimistic (hopeful) about life.
- ❖ To share ideas and discuss problems together, giving each other turns to talk.
- ❖ To engage adults for assistance when there are problems that needs to be solved.
- ❖ To pray for parents/guardians, peers, friends, relatives and all those who offer them services.
- ❖ To foster communication with peers, parents and teachers.

7.0 CHILD SAFETY

- 7.1 Ensure that the environment where children are engaged is safe e.g. no broken furniture, glass or litter which may cause harm to children.
- 7.2 Make sure that all staff and assistants know:

Where the emergency phone is and how it is operated.

Where the first aid kit is and how it is administered.

Who is responsible for first aid and how to record accidents or injuries in the incident book.

What to do in the event of a fire or any other emergency.

Take children through disaster drills in case of emergency

- 7.3 Do not let children go home with strangers unless there have been prior arrangements with the parents or guardians.
- 7.4 If private cars are used for an outing, the drivers must be approved by the management / committee, be properly insured, have rested before driving and should have a clean driver's license.

There should always be at least one other responsible person (18 years and above) in each vehicle. All vehicles should be fitted with seatbelts. Essentially, all vehicles used should meet the traffic safety regulations.

8.0 REPORTING PROCEDURES

- 8. I All Catholic institutions in Zimbabwe will use the Child Safe Standards to establish an adult Child Safeguarding Committee and a Child-led Committee which sets out in detail the internal policies, procedures and workplace systems it has adopted.
- 8.2 All Catholic Institutions staff members who identify concerns regarding the sexual, physical, psychological and emotional abuse or neglect of a child must respond according to mandatory reporting and grooming. Failure to disclose and failure to obey legislation and policies may come with repercussions.
- 8.3 When an allegation is directed against an employee (teachers, administrative staff, nurses, cooks, matrons, caregivers, grounds staff or any other staff member) staff members are to inform the Child Safeguarding Officer will handle the issue according to the laid down procedures.
- 8.5 The Heads of institutions shall ensure that staff members receive induction and on-going professional learning in relation to the child safety and protection policies and procedures, inclusive of mandatory reporting on an annual and on-going basis.
- 8.6 The Heads of institutions shall ensure the institutional pastoral care structures reflect all child safety and protection policies and procedures.

- 8.7 All Catholic institutions in Zimbabwe will create a Child Safeguarding Code of Conduct for staff and volunteers.
- 8.8 All Catholic institutions, staff members and volunteers will be required to follow guidelines in the Code of Conduct.

9.0 CHILDREN AND THE MEDIA

Maintaining respect and dignity of children and their families is the overriding principle in the use of information and visual images, both photographic and motion pictures, in our portrayal of children, families and communities. Any attempts to do so shall observe the following:

- 9.1 Obtain assent from the child and informed consent from the parents or guardians of the child before photographing or filming the child.
- 9.2 Explain how the video or photographs will be used.
- 9.3 That the photographs, films, videos and DVDs present children in a dignified and respectful manner and not in a vulnerable or submissive manner.
- 9.4 That images are honest representatives of the context and the facts.
- 9.5 Non-portrayal of children as helpless victims.
- 9.6 Photos and stories must not use real names of children or real location when communicating sensitive information, e.g. sexual abuse or violence.
- 9.7 Watching of television should be regulated by the parents/guardians and other caregivers in charge of children (games and stories that affect the mind and behavior negatively should be avoided)
- 9.8 Social media use must be monitored as it exposes children to abusive material like pornography, drug abuse and violence.

10.0 EXPECTED OUTCOME

- 10.1 Every Catholic institution in Zimbabwe should follow this blueprint, regarding child safety and protection.
- 10.2 All the members of the church (the faithful) will work respectfully and collaboratively with children, families and communities
- 10.3 Catholic employees are informed of child safety and protection and are expected to be self-aware and adhere to their professional obligations and responsibilities.
- 10.4 All allegations will receive a prompt response and be clearly documented.
- 10.5 Continuous spiritual support and counseling shall be availed to all those in need.


All children have the right to a thorough and systematic education in all aspects of personal safety in partnership with their parents, guardians or caregivers.
